ARRANGEMENT OF PARAGRAPHS

In exercise of the powers conferred by section 320(1A) of the Securities and Futures Act, the Monetary Authority of Singapore hereby makes the following Notification:

Citation and commencement

1. This Notification may be cited as the Securities and Futures (Appointment of Officers to Exercise Power to Grant Exemption) Notification 2005 and shall come into operation on 1st March 2005.

Appointed officers

2. The following persons are appointed by the Authority to exercise the power to grant an exemption to any person or in respect of any capital markets product, matter or transaction (not being an exemption granted to a class of persons or in respect of a class of capital markets products, matters or transactions) under a provision of the Act specified in the Fourth Schedule to the Act, or to revoke any such exemption:

- (a) an officer holding the office of Deputy Managing Director (Market Conduct);
- (b) an officer holding the office of Assistant Managing Director (Market Conduct);
- (c) an officer holding the office of Executive Director (Securities and Futures Supervision);
- (d) an officer holding the office of Executive Director (Market and Business Conduct).

Cancellation

3. The Securities and Futures (Appointment of Officers to Exercise Power to Grant Exemption) Notification 2003 (G.N. No. 2957/2003) is cancelled.
